I hereby assume any and all risks that would customarily and ordinarily occur by my participation in dog handling, dog movement or activities on site and consent to a release to the benefit of Western Slope Canines, LLC in consideration for my acceptance and participation in the program. I hereby waive and release Western Slope Canines, LLC, it's employees, owners, and agents, from any and all claims while on the grounds or surrounding area thereto, and resulting from participation in Western Slope Canines, LLC, including specifically, but without limitation, any injury or damage resulting from the action of any dog, including my own. I further agree to pay veterinary/medical expenses incurred as a result of injury caused by my dog(s). Western Slope Canines, LLC reserves the right to refuse service or terminate services of any pet at any time.

### **Guest Attendance Policy**

Family members and people that regularly interact with your canine are welcome and are in fact encouraged to attend training sessions. We do ask that only one person be present in the training area at a time unless instructed differently in the session. This is for the safety of everyone involved and to limit the distractions to the canines in the session.

### **Payment and Refund Policy**

Western Slope Canines, LLC accepts all payments in person. We accept: cash, check, and all major credit cards. Full payment is required after the class orientation for group classes and the initial consultation for private and private in-home training before the next scheduled class. Participants who fail to pay before the first official training day will be dropped from the class and will be required to reschedule. Clients requesting to retake a class that failed to meet their satisfaction must reschedule within 6 months or pay full price for the class again if desired.

### **Vaccination Requirements**

Western Slope Canines, LLC requires all dogs on property to be current on the following vaccinations: Rabies, DA2PP, and Bordatella. I understand that a current copy of my dog(s) vaccination record must be handed in, and approved, before my dog will be allowed to enter the property or leave my vehicle. Tags on collars will NOT be accepted without written documentation
